With the intent of binding myself, my spouse, my heirs, legal representatives, and assigns, I execute this Release as my own free act and deed.

Releasor, being of lawful age, in consideration of being permitted to participate in the Mitchell Technical College Lineman Rodeo, to be held at Mitchell Technical College, Mitchell, SD on April 24, 2026, do for myself, my spouse, my heirs, legal representatives and assigns, hereby release and forever discharge Mitchell Technical College, its elected and appointed officials, employees, students, agents and volunteers (hereinafter "Releasees"), and Releasees' officers, directors, stockholders, heirs, executors, administrators or legal representatives, or other successors in interest, of and from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or equity, arising from or by reason of said participation. Releasor waives the right to bring suit for and hereby assumes all risks of any bodily injuries, death, or property damage that may occur during or as a result of Releasor's participation in the Mitchell Technical College Lineman Rodeo or any activities in connection with the Mitchell Technical College Lineman Rodeo, whether caused by negligence of Releasees or otherwise. Releasor acknowledges that participation in the Mitchell Technical College Lineman Rodeo is completely voluntary.

Releasor further releases Releasees, other participants, and any professional person of any claim whatsoever on account of first aid, treatment or services rendered during his/her participation in the Mitchell Technical College Lineman Rodeo.

Releasor agrees to indemnify, defend and hold harmless the Releasees, their officers, directors, stockholders, employees and successors and interests and each of them from any loss, liability, damage or cost, including attorney's fees, they may incur due to the presence of Releasor in or upon the Mitchell Technical College Campus during the Mitchell Technical College Lineman Rodeo, whether caused by the negligence of Releasees or otherwise. Releasor further warrants and states that:

1. He/she has been thoroughly trained in climbing utility poles and in working on or atop utility poles without

supervision.

- 2. He/she is aware of and understands all safety regulations and rules applicable to servicing, repairing, replacing or otherwise working with or on electrical power lines and utility poles.
- 3. He/she will supply and use any and all equipment necessary for his/her participation in the Mitchell Technical College Lineman Rodeo, including, but not limited to, all hooks, belts, and hand tools.
- 4. He/she has inspected all of said equipment and tools, and he/she hereby states that they are in good condition, and that they are suitable and adequate for use in servicing, repairing, replacing or otherwise working with or on electrical power lines and utility poles.
- 5. He/she is aware of all risks and dangers involved in participation in the Mitchell Technical College Lineman Rodeo including, without limitation, all risks associated with climbing or working on or atop utility poles where no fall arresting system, safety nets or other such devices are in use, and the risks associated with the failure of personal protective equipment such as belts, hooks, hardhats and hand tools, and hereby states that his/her participation therein is voluntary.
- 6. He/she is acting of his/her own accord, and Releasees have in no way coerced, forced or suggested that Releasor participate in the International Lineman's Rodeo.
- 7. He/she hereby agrees and understands that Releasees have made no warranties as to the safety and condition at the International Lineman's Rodeo and have not made any representations and warranties as to the condition of the grounds or done any soil testing, and Releasor hereby agrees that he/she enters onto the property at his/her own risk and that Releasees are merely providing the ground to Releasor.
- 8. I acknowledge I have been advised and encouraged to purchase individual insurance to provide coverage for illness or injuries that I incur during participation in Mitchell Technical College Lineman Rodeo. I acknowledge that Mitchell Technical College does not provide any coverage for costs associated with illness or injuries sustained by me while participating in the Mitchell Technical College Lineman Rodeo.
- 9. I permit and hereby give my consent to the taking of photographs, audio and video tapes of me and/or my likeness during my participation in activities related to the Mitchell Technical College Lineman Rodeo and authorize the publication and use of such as the Mitchell Technical College deems appropriate.
